## *Board of Directors Meetings*

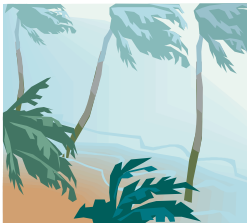
Your Board of Directors meet on the fourth Thursday of the first month of each quarter.

With your cooperation we can drastically reduce damages to our property by wind driven projectiles.

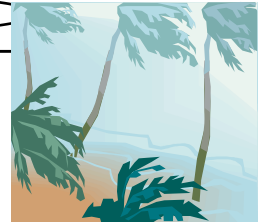
Please be sure that your unit has been properly closed for the season:
